REGULATED LOBBYIST SERVING ON A STATE BOARD OR COMMISSION DISCLOSURE OF INTEREST – (Form 23)

Pursuant to COMAR §19A.07.01.06, a regulated lobbyist who serves on a board or commission subject to the jurisdiction of the State Ethics Commission is required to disclose information regarding:¹

- 1. representation of a person for compensation before a State governmental unit, except in a judicial or quasi-judicial proceeding;
- 2. representation of a State agency for compensation, any contractual relationship with State government, or any transaction with State government for monetary consideration;
- 3. interests held by the regulated lobbyist, or his/her spouse or dependent children:
 - a. together or separately having either 10 percent or more of the capital stock or stock worth \$35,000 or more in a corporation subject to regulation by or doing business with the board or commission; or
 - b. in a partnership, limited liability partnership, or limited liability company subject to regulation by or doing business with the board or commission;
- 4. the primary employer of the spouse of the regulated lobbyist; and
- 5. the name of any business entity from which the regulated lobbyist or spouse of the regulated lobbyist receives earned income as a result of an ownership interest in the business.

Note: This form must be completed and forwarded to the Ethics Commission if <u>any</u> of the foregoing situations exist. Complete sections A, B, C, D and/or E as appropriate. If none exist, submission is not required.
