The meeting convened at 9:02 a.m. at 45 Calvert Street, 3rd Floor conference room. Those listed as present participated in all portions of the meeting unless otherwise noted. If other individuals participated in aspects of the meeting, they will be identified in the specific line item where their participation occurred.

ITEM 1: Tentative Agenda

Discussion: The Commission reviewed the tentative agenda.

Decision: The tentative agenda was approved as adjusted.

ITEM 2: Minutes of September 11, 2025, Meeting

Discussion: The draft minutes of September 11, 2025, meeting were reviewed and discussed.

Decision: The draft minutes were approved.

ITEM 3: Executive Director's Report – Update on New Training Modules

Discussion: Ms. Allgair briefed the Commission on the status of the training modules being developed by Maryland Public Television.

ITEM 4: Executive Director's Report – Financial Disclosure Program

Discussion: Ms. Allgair briefed the Commission on Financial Disclosure Coordinator training provided in October. Financial disclosure filer listings are being sent to agencies to update prior to the new filing year.

ITEM 5: Executive Director's Report – Lobbying

Discussion: Ms. Allgair briefed the Commission on the start of the new lobbying year beginning November 1, 2025. It appears the time-out issues we have had in the past have been resolved.

ITEM 6: Proposed Amendments to the Commission's Regulations

Discussion: Ms. Allgair briefed the Commission on the proposed amendments to the Commission's regulations that are currently in the AELR Committee to get approval in December which include: 19A.03.01.03 – Exemptions for Financial Disclosure Required by Members of Boards and Commissions; 19A.03.01.04 – Financial Disclosure Requirements for Members of Boards and Commissions; 19A. 04.03.03 - Local Government Review Procedures – Exemptions and Modifications; Subtitle 04 – Appendix A and B – Model Local Government Ethics Laws; 19A.05.03.01 – Board of Education Review Procedures; and Subtitle 05 – Appendix A and B – Model Board of Education Ethics Regulations. The draft is currently in the AELR Committee for approval in December. Also discussed were the proposed amendments to the Commission's regulations: 19A.06.01.02 – Blind Trusts – Applicability and Definitions, 19A.06.02 – Blind Trusts – Criteria for Certification; and 19A.06.03 – Blind Trusts – Procedural Requirements.

Decision: The Commission directed staff to continue work and present proposed amendments to the blind trust regulations at the January meeting.
