LOBBYIST FILING AGREEMENT

This Agreement, made this 27 day of 509, 2017, by and between Josh Tulkin, lobbyist for the Sierra Club, Maryland Chapter, and William J. Colquboun, Staff Counsel to the Maryland State Ethics Commission (hereinafter "Staff Counsel").

RECITALS

The State Ethics Commission ("the Commission") is the executive agency of the State of Maryland established by Chapter 513, Acts of 1979 for the purpose of enforcing the Maryland Public Ethics Law (General Provisions Article, Title 5, Annotated Code of Maryland, hereinafter the "Ethics Law") including the provisions of Subtitle 7, the lobbying disclosure program.

Josh Tulkin ("the filer") is an individual whose lobbying activities on behalf of the Sierra Club, Maryland Chapter, for the period November 29, 2016 to October 31, 2017, required him to register as a lobbyist with the State Ethics Commission.

On April 10, 2017, the Sierra Club, Maryland Chapter, held a reception for the members of the General Assembly.

The filer did not timely file Form 13E ("Five Day Report") within 5 days of the reception or a Form 13F ("Fourteen Day Report") for the reception within 14 days of the event, as required by Md. Code. Ann., Gen'l Prov., § 5-709(d)(1) (Supp. 2016).

The filer subsequently filed the Five Day Report on June 23, 2017 and the Fourteen Day Report on June 27, 2017.

The filer is voluntarily entering into this agreement to admit his failure to timely file a Five Day Report and a Fourteen Day Report with the Commission and to pay a sum of money in lieu of potential late filing fees and other fines pursuant to § 5-405 of the Ethics Law.

NOW THEREFORE, in consideration of the submission of the Five Day Report on June 23, 2017 and the Fourteen Day Report on June 26, 2017 by the filer, and the admissions and agreements herein contained, the filer and Staff Counsel stipulate and agree as follows:

- 1. The filer did not timely file a Five Day Report or a Fourteen Day Report in regard to the reception held by the employer as required by Md. Code. Ann., Gen'l Prov., §5-709(d)(1) (Supp. 2016).
- 2. The filer reported his delinquency to the Commission on May 31, 2017, and subsequently filed his Five Day Report and Fourteen Day Report. (Copies of each form have been attached hereto and made a part thereof.)

- 3. The filer understands that failure to comply with the lobbying disclosure provisions of the Public Ethics Law may subject him to a formal complaint by the Commission and, upon finding of a violation, late fees and the possibility of civil fines.
- 4. Based on the facts stated in this Agreement, the filer agrees to pay as settlement of the late filing matter, the amount of TWO HUNDRED FIFTY and no/100 DOLLARS (\$250.00) at the time of the execution of this Agreement in lieu of a potential late fees and in lieu of civil fines for the above admitted late Five Day Report and Fourteen Day Report. (Paragraph 1).
- 5. The Staff Counsel will, upon execution of this Agreement by the filer, recommend that the Commission not institute any proceedings for his failure to timely file. The filer understands that the Commission is under no obligation to accept this Agreement and may decide to take other action, including issuing a complaint.
- 6. The filer waives a formal hearing on this matter (if the Agreement is accepted by the Commission) to which he would be entitled if a complaint were issued, and he understands that this Agreement and materials relating to this matter are not subject to the confidentiality provisions of the Public Ethics law, and will be public information unless otherwise protected.
 - 7. The filer understands a copy of this Agreement will be mailed to his employer.
- 8. The filer and the Staff Counsel have entered into this Agreement for the sole purpose of resolving the late submission of a Five Day Report and a Fourteen Day Report and for the payment of late fees and other fines and for no other purpose.
